The undersigned is directed by order of the Governor to say that the Governor has been pleased to sanction a fund of Rs.10,000/- (Rupees ten thousand) only as Permanent Advance to each Sub-Divisional Land & Land Reforms Officer in the State for meeting expenditure of urgent nature in discharging day-to-day office works.

For management of the Permanent Advance a new sub-head "055-Land & Land Reforms" along with the detailed heads "09-Receipt/Reimbursement" and "10-Payment" has been opened under the head "8672-Permanent Cash Imprest-00-101-Civil" [Code for Receipt side: 8672-00-101-055-09 and Code for Payment side: 8672-00-101-055-10].

3. The concerned SDL & LROs will act as DDOs in respect of the Permanent Advance.

The PA fund will be drawn by the DDO by submission of bills in TR Form No.31 to the concerned Treasury/ PAO in terms of the provisions under Rule 4.114(2) of WBTR, 2005 under the above mentioned new head and bills for recoupment of the permanent advance will be drawn in TR Form No.25 and submitted to the Treasury/ PAO by the DDO in terms of Rule 4.114(1) of WBTR, 2005 under the head of account "2029-00-102-NP-003-13-04-V".

5. This order issues with the concurrence of the Pr. A.G (A & E), West Bengal, vide No. A.M.-I/3-37/XIV/1420 dt.05.01.2016 and Finance Department vide their Gr. 'T' U.O. No.0509 dt.17.09.2015 read with Gr. A-II U.O.No. 2015-2016 /0045 dt.18.09.2015 and Gr. 'R' U.O. No.1880 dt.16.10.2015.
